MOTION TO CONTINUE TRIAL DATE

Defendant (02) SHERRYANNE L. ST. CYR is present, not in custody.

Discussion held. All Counsel present at the hearing on their behalf and on behalf of others had no objections to the Motion (Doc. 325) nor were any written opposition objections filed.

THE COURT FINDS THAT THE ENDS OF JUSTICE SERVED BY SUCH AN ACTION OUTWEIGH THE BEST INTEREST OF THE PUBLIC AND THE DEFENDANT IN A SPEEDY TRIAL. THE COURT ORDERS THAT THE PERIOD FROM 2/28/2012 TO AND INCLUDING 8/28/2012 BE EXCLUDED FROM COMPUTATION UNDER THE SPEEDY TRIAL ACT AS A FAILURE TO GRANT THE CONTINUANCE WOULD UNREASONABLY DENY COUNSEL FOR THE DEFENDANT REASONABLE TIME NECESSARY FOR EFFECTIVE PREPARATION, TAKING INTO ACCOUNT THE EXERCISE OF DUE DILIGENCE.
